The expiration date of this agreement is June 20, _____. On or before this date, the undersigned agrees to do one of the following:

- A. Purchase a NEW instrument. Lease customers receive 100% of the first school year lease fee as a credit towards our discounted price. Minimum purchase required. Lease instruments are not sold. Lease credits are not cumulative.
- B. Renew the lease. This is at the option of Tigard Music.
- C. Return the instrument to Tigard Music. A late charge of \$2.00 per day, plus costs may be assessed after the due date.

Refunds:

Flute, Clarinet, Trumpet, Trombone, Violin, Viola, Drum Kit, and Percussion Kits are assessed a monthly fee of \$20.00. The Alto Sax fee is \$35.00. We just count how many months of use and subtract the use fee. You receive the balance as a refund. The Damage Waiver is a non refundable fee. Once the refund is granted the purchase credit is void.

Repairs and Replacement

Under this agreement Tigard Music will provide all repair work on the instrument required to keep it in good playing condition for the term of the agreement. Repair that exceeds normal wear and tear is billed at 70% of the regular shop rate. In the event Tigard Music considers the instrument to be damaged beyond repair, a replacement cost equal to 70% of the published retail price will be charged. This same charge will be made if the instrument is not returned as required. This agreement does not cover the replacement of any part of the instrument. Reeds, oils, greases, cleaning supplies, and/or mouthpieces/mouthpiece parts are not covered.
